RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF QUARTERLY LOCATORS' MEETINGS INCLUDING ORIENTATIONS AND SPOT INSPECTIONS

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated to approve BAC Resolution/s recommending award on behalf of the Head of Procuring Entity (HoPE) for procurement through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-019 from the Special Economic Zone Administrative Department (SEZAD) for the procurement of Catering Services for the conduct of Quarterly Locators' Meetings including Orientations and Spot Inspections. The Approved Budget for the Contract (ABC) for this procurement is Three Hundred Fifty Thousand Pesos (Php 350,000.00). A copy of the said request is attached as *Annex "A"*;

WHEREAS, in the approved Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-132 with mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted in the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals which were duly evaluated by the BAC;
