RECOMMENDING AWARD FOR THE PROCUREMENT OF SERVICES FOR THE DESIGN AND CONSTRUCTION OF THE BCDA-JHMC PANAGBENGA FLOAT FOR 2024

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to recommend to the Head of Procuring Entity (HOPE), and to ensure that the JHMC abides by the standards set forth by Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" and its 2016 Revised Implementing Rules and Regulations, to all its procurement activities;

WHEREAS, the BAC received Purchase Request (PR) No. 2024-004 from the Business Development Department (BDD) for the Procurement of Services for the Design and Construction of the BCDA-JHMC Panagbenga Float for 2024. The Approved Budget for the Contract (ABC) for this procurement is Eight Hundred Fifty Thousand Pesos (PhP850,000.00). A copy of the said request is attached as *Annex "A"*;

WHEREAS, in the approved Indicative Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-43 with mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted in the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received a proposal which was duly evaluated by the BAC:
