

CONTRACT AGREEMENT
*(Services for the Design and Construction of the
BCDA-JHMC Panagbenga Float for 2024)*

THIS AGREEMENT made this 01 FEB 2024 between **JOHN HAY MANAGEMENT CORPORATION** (hereinafter called "**JHMC**"), with principal office at John Hay Special Economic Zone, Loakan Road, Baguio City, of the one part and **MR. RUBEN C. ZAPARITA**, doing business under the name and style of **ZAPARITA'S GARDEN**, with office address at 3 Baguio Orchidarium, Burnham-Legarda, Baguio City (hereinafter called the "**SERVICE PROVIDER**") of the other part;


JOHN MICHAEL R. ZAPARITA


WHEREAS, **JHMC** invited bids for the Design and Construction of the BCDA-JHMC Panagbenga Float for 2024 (hereinafter called "the Services") and **JHMC** has accepted a bid by the **SERVICE PROVIDER** for Eight Hundred Forty Thousand Pesos (PhP840,000.00) for the execution and completion of such Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


RUBEN C. ZAPARITA

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Request for Quotation;
 - (b) Terms of Reference;
 - (c) Winning bidder's bid, eligibility requirements, and all other documents and/or statements submitted;
 - (d) Performance Security;
 - (e) Other contract documents that may be required by existing laws and/or **JHMC**. Winning bidder agrees that additional contract documents or information prescribed by GPPB that are subsequently required for submission after the contract execution shall likewise form part of the Agreement.
3. In consideration for the sum of **Eight Hundred Forty Thousand Pesos (PhP840,000.00)** or such other sums as may be ascertained, **SERVICE PROVIDER** agrees to design and construct the BCDA-JHMC Panagbenga Float Parade 2024. Provided, however, that the final design of the BCDA-JHMC Panagbenga Float shall be subject to the written approval of the JHMC Management, through the President and CEO. Provided, further, that the flower designs to be used in the float shall be turned over to **JHMC** after the Panagbenga Float Parade, without any additional cost to **JHMC**.
4. **JHMC** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
5. **Employment Relations.** There shall be no employer-employee relationship between **JHMC** and the **SERVICE PROVIDER**.





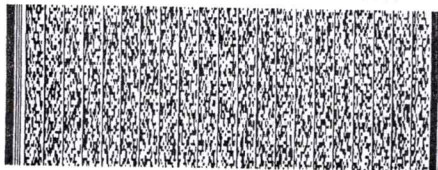
