RECOMMENDING AWARD FOR THE PROCUREMENT OF LEASE OF VENUE INCLUDING MEALS AND OTHER MATERIALS FOR THE JHMC'S DEPARTMENTAL PLANNING FOR CY 2025

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-079 from the Office of the President and Chief Executive Officer - Corporate Planning Unit (OPCEO-CPU) for the procurement of Lease of Venue Including Meals and Other Materials for the JHMC's Departmental Planning for CY 2025. WHEREAS, in the approved Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-135 with mode of procurement as Lease of Real Property and Venue (LRPV);
