
# CONTRACT AGREEMENT (Various ICT Equipment)

THIS AGREEMENT made this \_\_\_\_\_\_ between JOHN HAY MANAGEMENT CORPORATION, with office address at John Hay Special Economic Zone, Baguio City, Benguet, Philippines (hereinafter called "JHMC") of the one part and JONALYN P. LAURIAN, doing business under the name and style of HEXACOM ENTERPRISES, with office address at Stall 1 Adivay Bldg., Bonifacio St., Baguio City (hereinafter called "SUPPLIER") of the other part;

WHEREAS, JHMC invited Bids for certain goods and/or ancillary services, particularly procurement of various ICT equipment and has accepted a Bid by the SUPPLIER for the supply of those goods and/or ancillary services in the sum of One Million Two Hundred Four Thousand Eight Hundred Fifty Eight Pesos (PhP1,204,858.00), (hereinafter called "the Contract Price").

# NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - a. Scope of Services;
    - b. Technical Specifications;
    - c. General and Special Conditions of Contract; and
    - d. Supplemental or Bid Bulletins, if any.
  - ii. **SUPPLIER**'s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the JHMC's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the **SUPPLIER**'s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or **JHMC** in the PBDs. **SUPPLIER** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



In consideration for the sum of One Million Two Hundred Four Thousand Eight Hundred Fifty Eight Pesos (PhP1,204,858.00) or such other sums as may be ascertained, SUPPLIER agrees to deliver the goods in accordance with her Bid.

4. JHMC agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

- To ensure continuing compliance with tax laws pursuant to Executive Order 5 No. 398:
  - The SUPPLIER shall pay taxes in full and on time, failure to do so will entitle JHMC to suspend payment.
  - The SUPPLIER is likewise required to submit, prior to the execution the Agreement, a tax clearance from the Bureau of Internal Revenue (BIR) as well as a copy of her income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made thereon.
- 6. Employment Relations. There shall be no employer-employee relationship between JHMC and the SUPPLIER.

The SUPPLIER represents and acknowledges that the Services being engaged and offered to JHMC are strictly for and in relation to the specified Project of JHMC.


