RECOMMENDING AWARD FOR THE PROCUREMENT OF REAL-TIME KINEMATIC (RTK) SURVEY EQUIPMENT "ROVER"

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-066 from the Environment and Asset Management Department – Land and Asset Management Division (EAMD-LAMD) for the procurement of Real-Time Kinematic (RTK) Survey Equipment "ROVER". The Approved Budget for the Contract (ABC) for this procurement is Seventy Thousand Pesos (PhP70,000.00). A copy of the said request is attached as *Annex* "A";

WHEREAS, in the approved Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-018 for the 'Real-Time Kinematic (RTK) Survey Equipment "ROVER" with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto. JHMC received only one (1) proposal:
