RECOMMENDING AWARD FOR THE PROCUREMENT OF GARDENING AND GENERAL FOREST CARE SERVICES

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to recommend and to ensure that the JHMC abides by the standards set forth by Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" and its Revised Implementing Rules and Regulations (RIRR), to all its procurement activities;
